

After which time entries cannot be accepted, cancelled, altered or substituted except as provided for in Chapter 11, Section 6 of the Rules Applying to Dog Shows published by The American Kennel Club. Changes, additions or corrections to entry forms must be received in writing prior to close of entries at vizslafuturitymaturity@gmail.com.

Entries received 1) prior to the published opening date and time for entries or 2) received prior to the publishing of this premium list or 3) after the published closing date and time for entries will be returned without processing.

#### **ADDITIONAL RULES:**

Vizsla Breeders' Cup, Inc. Rules apply throughout Vizsla Futurity-Maturity Recognition event. Judging will follow the Rules Applying to Dog Shows published by The American Kennel Club <a href="https://images.akc.org/pdf/rulebooks/RREGS3.pdf">https://images.akc.org/pdf/rulebooks/RREGS3.pdf</a>, amended January 2024.

AKC Registration Number is required for all entries of Vizslas into the Vizsla Futurity-Maturity Recognition Show.

Committee Members of Vizsla Breeders' Cup, Inc. are eligible to enter and compete at this show.

All entrants must be vaccinated (including rabies) in accordance with their local Veterinary Protocols and free of internal and external parasites as well as any communicable diseases. Entrants should carry proof of all vaccinations.

Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs will be allowed in rings during judging only. Judge need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence and readiness of their dogs in the judging rings.

#### DECLINED CREDIT/DEBIT CARDS do not constitute a valid entry fee.

**Entry Fees** – Entries received without fees will not be accepted; Invalid credit/debit cards do not constitute a valid entry. Entry Fee will not be refunded for Duplicate Entries if entry has been processed. Vizsla Breeders' Cup, Inc. will make every attempt to identify any duplicate entries.

Entry Fee will <u>not</u> be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge or barred from competition by action of the Show Committee. Force Majeure - No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Vizsla Breeders' Cup, Inc. If an entry is cancelled prior to closing date and time, refunds will be provided, excepting a \$3.00 administrative/processing fee per entry.

Entries will be acknowledged as soon as practicable after entry fees are verified. If Exhibitor does not receive acknowledgement within a reasonable timeframe, please contact Vizsla Breeders' Cup, Inc. at vizslafuturitymaturity@gmail.com.

Exhibitors accept that they present their dogs/bitches at their own risk. Vizsla Breeders' Cup, Inc., the show giving Club, the Show Superintendent, their agents, employees, etc. assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assume no responsibility for injury to children.

## Judge Biography Eileen Wilkes

Eileen Wilkes has been engaged with the Vizsla breed since the early 1990s, when she imported her first Vizslas from England, working with the Gardenway Kennel. Since then, combining pedigrees from around the world, she has bred and raised many Vizslas under the name of Ferngold Vizslas. As a result of Eileen's efforts over the years, she has produced a multitude of Conformation Show ring winners in both Canada and the USA. Eileen held many positions with the Vizsla Society of Ontario including Vice President, Standards Committee and Show Chair. Working on the Standards Committee, she performed a comparison of Vizsla Conformation Standards from Canada, USA, England, and Hungary. She is well versed in all of these Conformation Standards. Eileen was also one of the founding members of Vizsla Canada.

Eileen looks forward to judging our Vizslas in the Vizsla Breeders' Cup for the 2024 Vizsla Futurity-Maturity Recognition Competition.

### **Futurity Competition Eligibility**

For a Puppy to be eligible to compete in the Futurity Competition of 2023 Vizsla Futurity-Maturity Recognition, it must satisfy all the following requirements:

- 1. Whelped in a litter which was nominated and accepted according to Vizsla Breeders' Cup, Inc. Rules.
- 2. Nominated Individually and accepted under Vizsla Breeders' Cup, Inc. Rules.
- 3. Has not competed in a previous Futurity Show/Event. A puppy may only compete once in a Futurity Show/Event; This includes entering a Vizsla Futurity-Maturity Recognition Show/Event, but not appearing for judging.

Should any questions of eligibility surface, Breeder(s) and/or Owner(s) should retain all pertinent information and correspondence regarding:

- a. Litter Nomination & Acceptance (Including proof of all payments of nomination fees).
- b. Individual Dog/Bitch Nomination & Acceptance (Including proof of all payments of nomination fees).

Nomination acceptance of a puppy must be made available to Vizsla Breeders' Cup, Inc. Administration to resolve any errors, protests, or conflicts. Failure to provide this documentation could result in the puppy in question being disqualified from competition due to lack of proof of eligibility. Vizsla Breeders' Cup, Inc. will be responsible to rule on any protest or conflict regarding an entry to Vizsla Futurity-Maturity Recognition based upon the evidence and/or documentation at hand. Vizsla Breeders' Cup, Inc. ruling will be final without further appeal or protest.

## **Maturity Competition Eligibility**

For a Dog/Bitch to be eligible to compete in the Maturity Competition of 2023 Vizsla Futurity-Maturity Recognition, it must satisfy all the following requirements:

 Whelped in a litter which was nominated and accepted according to Vizsla Breeders' Cup, Inc. Rules during Years 2018, 2019, 2020, 2021 or 2022 and aged 18 Months Plus One Day or Older.

- 2. Nominated Individually and accepted under Vizsla Breeders' Cup, Inc. Rules.
- 3. Has not competed in a previous Maturity Show/Event. A dog/bitch may only compete once in a Maturity Show/Event; however, it is not required that a dog/bitch has previously participated in the Futurity Competition. This includes entering a Vizsla Futurity-Maturity Recognition Show/Event, but not appearing for judging.

Should any questions of eligibility surface, Breeder(s) and/or Owner(s) should retain all pertinent information and correspondence regarding:

- a. Litter Nomination & Acceptance (Including proof of all payments of nomination fees).
- b. Individual Dog/Bitch Nomination & Acceptance (Including proof of all payments of nomination fees).

Nomination acceptance of a dog/bitch must be made available to Vizsla Breeders' Cup, Inc. Administration to resolve any errors, protests, or conflicts. Failure to provide this documentation could result in the dog/bitch in question being disqualified from competition due to lack of proof of eligibility. Vizsla Breeders' Cup, Inc. will be responsible to rule on any protest or conflict regarding an entry to Vizsla Futurity-Maturity Recognition based upon the evidence and/or documentation at hand. Vizsla Breeders' Cup, Inc. ruling will be final without further appeal or protest.

#### **SOUTH CONGAREE HORSE ARENA**

The arena will be available to exhibitors according to the rules set forth in the Premium for Vizsla Club of the Carolinas Indian Summer Specialties. Dogs/Bitches must be removed from the show site also according to the timeframes set forth in that Premium.

Crating, Exercise Pens, & grooming areas will be defined by the Vizsla Club of the Carolinas. Crates must be stacked with safety as the height guideline. Exhibitors are expected to keep their grooming & crating area clean. All other expectations are set forth by Vizsla Club of the Carolinas Indian Summer Specialties in the Premium.

Exhibitors with dogs/bitches accept that videos and/or pictures may be obtained and used on social media or by Vizsla Club of the Carolinas or Vizsla Breeders' Cup, Inc. By entry into Vizsla Futurity-Maturity Recognition, Exhibitor accepts that his/her image as well as that of dog/bitch may be utilized by Vizsla Club of the Carolinas or Vizsla Breeders' Cup, Inc.

Parking for Exhibitors is ample and free. The covered area is reserved for committee members of Vizsla Club of the Carolinas Indian Summer Specialties and handicapped individuals.

Food Service may be provided by Vizsla Club of the Carolinas Indian Summer Specialties. There are a few fast food restaurants in the immediate area.

#### TROPHIES & MONETARY AWARDS

Trophy Sponsors are needed; A donation to the General Fund is appreciated.

Trophies may be provided at the discretion of the friends and associates of Vizsla Futurity-Maturity Recognition. All trophy sponsors, as appropriate, will be listed in the event catalog. Vizsla Breeders' Cup, Inc. reserves the right to substitute an alternative trophy of equal or greater value, if necessary.

All trophies must be claimed the day of the show, none will be mailed.

## **Monetary Prize Awards**

- A. Starting with the Futurity-Maturity Recognition Show on September 20, 2024, Prize Money will be awarded according to the following details:
  - Background Vizsla Breeders' Cup consists of the following fees with listed purposes:
    - Litter Nomination Used for the ongoing administration of Vizsla Breeders' Cup. This includes Incorporation Fees, Taxes, Hosting of Forms, etc.
    - 2. Individual Dog/Bitch Nomination Used strictly for Monetary Prize Awards & divided equally between Futurity (50%) and Maturity (50%) Awards.
    - 3. Show Entry Used for the administration of the annual Vizsla Futurity-Maturity Recognition Show. This administration includes expenses related to Judge's Fees, Host Club Fees, etc.
  - ii. Monetary Prize Awards Prize Awards will be calculated according to the following schedule:
    - 1. Futurity
      - a. Best Puppy Dog 10%
      - b. Best Puppy Bitch 10%
      - c. Best Junior Dog 10%
      - d. Best Junior Bitch 10%
      - e. Best Futurity Puppy 15%
      - f. Best Futurity Junior 15%
      - g. Grand Futurity Winner 30%
    - 2. Maturity
      - a. Best Maturity Dog 30%
      - b. Best Maturity Bitch 30%
      - c. Grand Maturity Winner 40%
    - 3. Distribution of the Monetary Prize Awards (per percentages above) will be further allocated to the Winning a) Breeder, b) Owner & c) Sire Owner according to the following categories:
      - a. Breeder 50%
      - b. Owner 30%
      - c. Sire Owner 20%
  - iii. Delivery of Monetary Prize Awards Checks for Monetary Prize Awards will be delivered to the individual who is listed as the Primary Breeder, Primary

Owner and/or Primary Sire Owner of record on the Litter Nomination form when it was entered. Any changes to the initial Litter Nomination should be delivered timely to Joyce Jackson at vizslafuturitymaturity@gmail.com. Any further distribution of Monetary Prize Award to co-breeders or co-owners of any of the categories listed above is the sole responsibility of the Primary Breeder, Primary Owner and/or Primary Sire Owner to whom the award check was delivered.

**FROM I-77** – Take I-26 West and then follow "Next Directions" below.


**FROM I-20** – Take I-26 East and then follow "Next Directions" below.

**FROM Columbia Metro Airport** – Follow the Exits to Hwy 302, then turn Right and follow "Next Directions" below.

#### **Next Directions –**

**From I-26 (East or West)** – Take Exit 113 and go towards South Congaree/Columbia Metro Airport on Hwy 302.

Travel approximately 4 Miles, then turn left onto Ramblin Road. At 0.1 Miles, turn right on Oak Street. The site is on the Left.
